***Indictments Returned on Thursday, August 31, 2017
By the Special Session of the May, 2017 Term of the Berkeley County Grand Jury***

MARTINSBURG, WV – A Special Session of the May 2017 Grand Jury was convened August 31, 2017. The Grand Jury returned indictments against the following individuals, who are presumed innocent unless and until proven guilty:

NATHAN ALEX ASTRAYKA, age 22, of Martinsburg, West Virginia, was charged with Transporting a Controlled Substance into the State, Possession with Intent to Deliver Heroin, Conspiracy to Transport a Controlled Substance into the State, and Petit Larceny.

CODY BRANDON KYNE, age 22, of Martinsburg, West Virginia, charged with Transporting a Controlled Substance into the State, Possession with Intent to Deliver Heroin, and Conspiracy to Transport a Controlled Substance into the State. KYNE was also charged in separate indictments with Burglary, Transferring Stolen Property and Petit Larceny.

MARIAH A. ELDER, age 21, of Martinsburg, West Virginia, was charged with eight counts of burglary, eight counts of Destruction of Property, five counts of Petit Larceny, two counts of Grand Larceny, Conspiracy to Commit Burglary and Transferring Stolen Property.

LAUREN ELIZABETH MYERS, age 28 of Hedgesville, West Virginia, was charged with Accessory After the Fact to a Felony and Transferring Stolen Property

DILLON A. NUSBAUM, age 25 of Hedgesville, West Virginia, was charged with eight counts of burglary, eight counts of Destruction of Property, five counts of Petit Larceny, two counts of Grand Larceny, and Conspiracy to Commit Burglary

BILLY EDWARD EVANS, age 35, of Martinsburg, West Virginia, was charged with Attempted Murder, six counts of Malicious Assault, and five counts of Wanton Endangerment.

WILLIS HENRY GRANT, III, age 47, of Martinsburg, West Virginia, was charged with six counts of Sexual Assault in the First Degree, five counts of Sexual Abuse by a Parent, Guardian, or Custodian, five counts of Incest, and one count of Sexual Abuse in the First Degree.

SENBAD M. JACKSON, age 33, of Martinsburg, West Virginia, was charged with four counts of Breaking and Entering and four counts of Conspiracy to Commit Breaking and Entering.

JEFFERY LEE POTTER, age 31, of Martinsburg, West Virginia, was charged with four counts of Breaking and Entering and four counts of Conspiracy to Commit Breaking and Entering.

ABDUL KAMARA, age 28, of Dumfries, Virginia, was charged with Possession with Intent to Deliver Marijuana, Transporting a Controlled Substance into the State, Conspiracy to Commit Possession with Intent to Deliver Marijuana, and Possession of a Firearm by a Prohibited Person.

JOSHUA SHAINÉ MOORE, age 26, of Alameda, California, was charged with Possession with Intent to Deliver Marijuana, Transporting a Controlled Substance into the State, and Conspiracy to Commit Possession with Intent to Deliver Marijuana.

SHANIQUA ROSEANN WHINDLETON, age 25, of Petersburg, Virginia, was charged with Possession with Intent to Deliver Marijuana, Transporting a Controlled Substance into the State, and Conspiracy to Commit Possession with Intent to Deliver Marijuana.

LAUREN EMILY LILLY, age 32, of Frederick, Maryland, was charged with two counts of Uttering

LARRY ALLEN PARKINSON, age 53, of Martinsburg, West Virginia, was charged with Malicious Assault, Breaking and Entering, Petit Larceny, Third Offense Driving While License Revoked for DUI, and Possession of a Controlled Substance.

RONNIE LEE SCHROYER, age 57, of Martinsburg, West Virginia, was charged with Bank Robbery and Kidnapping.

CHRISTOPHER DEVON SEMLER, age 29, of Martinsburg, West Virginia, was charged with Third Offense for Driving Under the Influence of Alcohol, Fleeing Law Enforcement in a Vehicle While DUI, and Improper Use of a Vehicle Registration.

All charges contained in the above-referenced indictments are merely accusations and not evidence of guilt. Each defendant is presumed innocent until and unless proven guilty.
