***Indictments Returned on Wednesday, October 18, 2017
By the October, 2017 Term of the Berkeley County Grand Jury***

MARTINSBURG, WV – The October 2017 Term of Grand Jury reconvened to continue deliberations and returned indictments against the following individuals, who are presumed innocent unless and until proven guilty:

DERRICK DWAYNE BERRY, age 41, of Charles Town, West Virginia, was charged with three counts of Sexual Abuse in the First Degree, seven counts of Sexual Abuse by a Parent Guardian, Custodian, or Person in Position of Trust, three counts of Sexual Assault in the First Degree, and Attempted Sexual Assault in the First Degree.

EDGAR B. BROWNE, IV, age 44, of Bunker Hill, West Virginia, was charged with three counts of Third Offense Driving While License Revoked for DUI, two counts of DUI Resulting in Serious Bodily Injury, Second Offense for Driving Under the Influence of Alcohol, and Possession of a Controlled Substance.

GARLAND EDWARD CLEM, JR., age 53, of Bunker Hill, West Virginia, was charged with Failure to Pay Child Support.

RUSSELL WALTER COLLINS, age 24, of no fixed address, was charged with Strangulation, four counts of Domestic Battery, unlawful restraint, and two counts of Violation of Domestic Violence Protective Order.

TITO ISMAEL ARITA CRUZ, age 29, of Columbia, Maryland, was charged with five counts of Sexual Assault in the Third Degree.

TRAVIS HAYES, age 30, of Martinsburg, West Virginia, was charged with two counts of Strangulation, Child Abuse Causing Bodily Injury, two counts of Domestic Battery, two counts of Domestic Assault, and Obstructing an Officer.

BRENT EDWARD KIMBALL, age 32, of Inwood, West Virginia, was charged with two counts of Third Offense Driving While License Revoked for DUI, Third Offense for Driving Under the Influence of Alcohol, DUI with Minors in Vehicle, and two counts of Gross Child Neglect Creating Substantial Risk of Serious Bodily Injury.

JEFFERY LINEBERG, age 57, of Martinsburg, West Virginia, was charged with twenty counts of Fraudulent Use of an Access Device.

TERRY LEE MASON, JR., age 30, of Martinsburg, West Virginia, was charged with Delivery of Heroin, Possession with Intent to Deliver Heroin, Possession with Intent to Deliver Methamphetamine, and Conspiracy to Commit Possession with Intent to Deliver Heroin.

JEFFREY TODD MILLER, age 48, of Martinsburg, West Virginia, was charged with two counts of Delivery of Heroin and Possession with Intent to Deliver Heroin.

TROY LYNN MYER, age 39, of Martinsburg, West Virginia, was charged with twenty-nine counts of Identity Theft and one count of Felony Fraudulent Scheme.

DAVID W. MYERS, age 41, of Hedgesville, West Virginia, was charged with Burglary, Conspiracy to Commit Burglary, and Grand Larceny.

YUNIELKIS TERRERO NOA, age 33, of Palm Springs, Florida, was charged with DUI Resulting in Serious Bodily Injury.

ANGEL IRENE PECK, age 21, of Martinsburg, West Virginia, was charged with Possession with Intent to Deliver Heroin.

BETTY CATHERINE POLAND, age 23, of Falling Waters, West Virginia, was charged with Burglary and Grand Larceny.

TAYLOR WOLF PORTERFIELD, age 23, of Inwood, West Virginia, was charged with Grand Larceny, Fleeing from a Law Enforcement Officer in a Vehicle, Driving While License Suspended or Revoked, and Possession of a Controlled Substance.

GREGORY MICHAEL ROBERTSON, age 44, of Falling Waters, West Virginia, was charged with Felony Obtaining Money or Goods by False Pretense.

CHARLES MICHAEL ROBINSON, age 28, of Sterling, Virginia, was charged with Possession with Intent to Deliver Crack Cocaine and Conspiracy to Possession with Intent to Deliver Crack Cocaine.

WILLIAM LEE ROBINSON, age 47, of no fixed address, was charged with Third Offense Shoplifting.

LAFFIE JAMES ROOP age 32, of Inwood, West Virginia, was charged with Burglary and Grand Larceny.

KAYLA NICOLE ROSE, age 20, of Martinsburg, West Virginia, was charged with Possession with Intent to Deliver Heroin, Possession with Intent to Deliver Cocaine and Conspiracy to Commit Possession with Intent to Deliver Cocaine.

CATHY ANN TOMASIK, age 49, of Gerrardstown, West Virginia, was charged with fourteen counts of Forgery and Conspiracy to Forgery.

STEVEN EDWARD TOMASIK, age 53, of Inwood, West Virginia, was charged with fifteen counts of Forgery, Uttering and Conspiracy to Forgery.

CLIFFORD WHEELER, age 58, of Martinsburg, West Virginia, was charged with Possession with Intent to Deliver Heroin and Possession with Intent to Deliver Oxycodone.

JAMES WESLEY WILSON, age 31, of Gerrardstown, West Virginia, was charged with Malicious Assault.

MARK HOWARD WRIGHT, age 35, of Gerrardstown, West Virginia, was charged with two counts of Domestic Battery Third Offense and Obstructing an Officer.

All charges contained in the above-referenced indictments are merely accusations and not evidence of guilt. Each defendant is presumed innocent until and unless proven guilty.
