### **Indictments Returned on Thursday, February 22, 2018 By the February, 2018 Term of the Berkeley County Grand Jury**

MARTINSBURG, WV – On February 22, 2018, the February 2018 term of Grand Jury reconvened for a final time at the Berkeley County Judicial Center. On Thursday, the Grand Jury returned indictments against the following individuals, who are presumed innocent until and unless proven guilty:

REGINALD LAMONT ALSTON, age 38, of Falling Waters, West Virginia, was charged with Delivery of Heroin, Possession with Intent to Deliver Heroin, and Possession with Intent to Deliver Crack Cocaine.

KENNETH WAYNE BOWERS, age 50, of Martinsburg, West Virginia, was charged with Domestic Battery Third Offense

KAYLA MARIE BOWERS, age 27, of Inwood, West Virginia, was charged with Child Abuse Causing Injury and Malicious Assault.

CHRISTOPHER TYSON COOK, age 34, of Martinsburg, West Virginia, was charged with Delivery of Heroin.

BILLY EDWARD EVANS, age 36, of Martinsburg, West Virginia, was charged with Failure to Appear.

KHALEEL JAHMAL GRAHAM, age 21, of Martinsburg, West Virginia, was charged with Arson in the First Degree and five counts of Attempted Murder.

JOSEPH MARK GWYNN, age 31, of Mechanicsville, Maryland, was charged with two counts of Possession with Intent to Deliver Heroin, Conspiracy to Possess with the Intent to Distribute Heroin, and Possession with Intent to Deliver Crack Cocaine.

DAMEON LEE HAIRSTON, age 38, of Martinsburg, West Virginia, was charged with Possession with Intent to Deliver Marijuana and Possession with Intent to Deliver Buprenorphine.

RUSSELL E. HAMILTON, age 53, of Martinsburg, West Virginia, was charged with Third Offense for Driving Under the Influence of Alcohol and Driving While License Revoked for DUI.

ISRAEL H. LOGAN, age 20, of Inwood, West Virginia, was charged with Robbery First Degree.

TERRY LEE MASON, JR., age 30, of Martinsburg, West Virginia, was charged with Delivery of Heroin, Conspiracy to Deliver Heroin, and Possession with Intent to Deliver Heroin.

GLEN MOSES MILLER, JR., age 45 of Inwood, West Virginia, was charged with ten counts of Felony Worthless Check.

DUANE MILLARD OLIVER, JR., age 29, of Martinsburg, West Virginia, was charged with Possession with Intent to Deliver Heroin, Possession with Intent to Deliver Cocaine, Possession with Intent to Deliver Methadone, Possession with Intent to Deliver Oxycodone, Possession of Marijuana, Driving Under the Influence, and Driving While License Suspended or Revoked (Non-DUI) Third Offense.

PAUL RAY PIPES, age 44, of Martinsburg, West Virginia, was charged with eight counts of Sexual Assault in the Third Degree and Soliciting a Minor Via a Computer.

JODY LEE SHANHOLTZ, age 45, of Martinsburg, West Virginia, was charged with eleven counts of Fraudulent Use of an Access Device and eleven counts of Conspiracy to Commit Fraudulent Use of an Access Device.

STEPHANIE RENEE SHANHOLTZ, age 33, of Martinsburg, West Virginia, was charged with twelve counts of Fraudulent Use of an Access Device and eleven counts of Conspiracy to Commit Fraudulent Use of an Access Device.

LISA MAE SMITH, age 43, of Martinsburg, West Virginia, was Embezzlement and three counts of Forgery and three counts of Uttering

Superseding indictments were also presented to the February 2018 term of Grand Jury. A superseding indictment is an indictment that takes the place of, takes precedence over, or replaces a previously obtained indictment. A superseding indictment was issued against the following individual, who is presumed innocent until and unless proven guilty:

STEVEN T. BROWN, age 24, of Martinsburg, West Virginia, was charged with Sexual Abuse in the First Degree and Attempted Sexual Assault in the Second Degree.

Over the course of three days, a total of 62 of indictments were returned by the February, 2018 Term of the Berkeley County Grand Jury
