Indictments Returned By the October, 2018 Term of the Berkeley County Grand Jury

MARTINSBURG, WV – Berkeley County Prosecuting Attorney Catie Wilkes Delligatti announces that on Tuesday, October 23, 2018, the October 2018 term of Grand Jury was convened at the Berkeley County Judicial Center. The Grand Jury has returned a total of ninety-nine (99) indictments between Tuesday and Thursday, October 25.

All individuals are presumed innocent unless and until proven guilty.

Indictments were returned against the following individuals for the following counts.

BRIAN SCOTT ADAMS, 34, of Martinsburg, West Virginia, was charged with Operate or Attempt to Operate a Clandestine Drug Laboratory, Conspiracy to Operate a Clandestine Drug Laboratory, Manufacture of Methamphetamine, and Conspiracy to Manufacture Methamphetamine.

NICHOLAS JACOB AILSHIE, 24, of Martinsburg, West Virginia, was charged with Robbery in the First Degree, Conspiracy to Commit Robbery, Malicious Assault, and Assault During the Commission of a Felony.

DAVID TODD WALLS, 51, of Martinsburg, West Virginia, was charged with Fleeing from a Law Enforcement Officer While DUI, Fleeing from a Law Enforcement Officer with Reckless Indifference, Driving Under the Influence of Alcohol, Reckless Driving, Flee from Law Enforcement Officer by Means Other than Use of Vehicle, Obstructing an Officer, and Domestic Assault.

JOSEPH P. WALTERS, 50, of Hancock, Maryland, was charged Transport of a Controlled Substance into the State, Possession with Intent to Deliver Heroin, and Conspiracy to Transport a Controlled Substance into the State.

DONALD R. WATSON, JR., 58, of Martinsburg, West Virginia, was charged with two counts of Distribution of Heroin and two counts of Conspiracy to Distribute Heroin.

LADELL DEMONT WEBB, 39, of Martinsburg, West Virginia, was charged with Felony DUI Resulting in Death, Reckless Driving, Speeding, Failure to Maintain Control of Vehicle, and Providing False Information to Law Enforcement Officer.

NATHAN JAMES WILDMAN, 24, of Martinsburg, West Virginia, was charged with Arson in the First Degree and Attempted Murder.

ROBERT JAMES WILSON, 32, of Inwood, West Virginia, was charged with Arson in the First Degree, Felony Transferring Stolen Property, and Grand Larceny.

All charges contained in the above-referenced indictments are merely accusations and not evidence of guilt. Each defendant is presumed innocent until and unless proven guilty.
