## Indictments Returned By the February, 2019 Term of the Berkeley County Grand Jury

MARTINSBURG, WV – Berkeley County Prosecuting Attorney Catie Wilkes Delligatti announces that on Tuesday, February 19, 2019, the February 2019 term of Grand Jury was convened at the Berkeley County Judicial Center. Grand Jury deliberations lasted through Friday. The Grand Jury returned a total of fifty (50) indictments.

Indictments were returned against the following individuals for the following counts.
