BERKELEY & JEFFERSON COUNTIES, WEST VIRGINIA – Multiple individuals were arrested today and charged with facilitating an extensive heroin trafficking network spanning the Eastern Panhandle and surrounding states, according to Jefferson County Prosecutor Matthew L. Harvey and Berkeley County Prosecutor Catie Wilkes Delligatti.

Arrests made today were based upon warrants alleging that a group of individuals conspired with one another to operate a heroin distribution ring in the region. Officers utilized a variety of investigative tools to uncover the communication and travel patterns underlying the drug distribution operation including a wire interception of electronic communications and ground/aerial surveillance.

This morning, warrants were served based upon 496 Berkeley County charges and 72 Jefferson County charges culminating in the arrests of 49 individuals via a coordinated, multi-agency arrest operation led by the Eastern Panhandle Drug & Violent Crime Task Force, with participating agencies including the West Virginia State Police, FBI, Berkeley County Sheriff's Department, Jefferson County Sheriff's Department, Martinsburg City Police Department, Charles Town Police Department, Ranson Police Department, ATF, and United States Marshal's Service.
