Indictments Returned By the October, 2019 Term of the Berkeley County Grand Jury

MARTINSBURG, WV – Berkeley County Prosecuting Attorney Catie Wilkes Delligatti announces that on Tuesday, October 15, 2019, the October 2019 term of Grand Jury was convened at the Berkeley County Judicial Center. Grand Jury deliberations lasted through Friday. The Grand Jury returned a total of 114 indictments.

Indictments were returned against the following individuals for the following counts.

STEPHANIE L. WHETZEL, 34, of Martinsburg, West Virginia, was charged with three counts of Cruelty to Animals.

MICHAEL LEE WHITE, 56, of Martinsburg, West Virginia, was charged with six counts of Distribution of Fentanyl and Distribution of Heroin.

All charges contained in the above-referenced indictments are merely accusations and not evidence of guilt. Each defendant is presumed innocent until and unless proven guilty.
