Probate Requirements WITH Original Will/Codicil(s) West Virginia Code Chapter 44

You must apply for appointment in person with a Valid Photo ID no later than 4:00 PM.

Immediate Appointment of Executor/ix is not possible in every situation.

Certified copy of the state issued Death certificate required (WV Code 44-1-30). Berkeley County must be listed as the decedent's residence

Originally signed Will, not a copy, should be delivered to this office within 30 days of death, preferably by the named Executor/ix.

Witness depositions as well as waivers and/or **bond may be required. Fiduciary Staff will advise.

** Wills generally waive a Surety Bond for named Executors. Otherwise unless applicant is sole beneficiary under the Will a Surety Bond is required. A WV Resident may post property or corporate bond. Corporate Bond required for non-resident.

Complete Page 2 – Estimate of Probate Estate (To the best of your knowledge).

Complete Page 3 – Address & Relationship to decedent, if any, of each beneficiary named in the Will. Include Address/Contact Information for Charitable Organizations, Churches, Trustees etc.

Additional information may be required for named beneficiaries who are also deceased.

Appointment and Recording Fees – See Page 4 – Range: \$52.00 to \$202.00+

Your **FIRST TWO** administrative costs are combined and due at the time of your appointment. Payment accepted in the form of check, money order or cash only.

A. APPOINTMENT Fee (WV Code 44-3A-42)

Estate up to \$10,000	\$25.00
Estates over \$10,000 but not exceeding \$50,000	\$100.00
All estates over \$50,000	\$175.00
Testamentary Trustee/Guardian/Misc.	\$25.00

B. *RECORDING Fee (WV Code 59-1-10 & SA-8-15)

Will/Codicils	\$12.00**
Executor/ Administrator Application/ Affidavit & Oath	\$17.00**
Testamentary Trustee/Guardian/Misc.	\$12.00**

^{**} If documents **EXCEED** five (5) pages the recording fee is increased.

Cost of corporate surety bond is additional.

All costs of administration are **reimbursable** as **probate** funds may be available.
