***Indictments Returned on Tuesday, October 17, 2017
By the October, 2017 Term of the Berkeley County Grand Jury***

MARTINSBURG, WV – On October, 17, 2017, the October 2017 term of Grand Jury was convened at the Berkeley County Judicial Center. Grand Jury deliberations are expected to last three days. On Tuesday, the Grand Jury returned indictments against the following individuals, who are presumed innocent unless and until proven guilty:

DARNELL ALLEN, age 36, of Martinsburg, West Virginia, was charged with Possession of a Firearm by a Prohibited person and Possession of a Controlled substance.

DAKOTA ALLERTON, age 23, of Martinsburg, West Virginia, was charged with Robbery First Degree, Conspiracy to Commit Robbery, and Assault During the Commission of a Felony.

TERESA L. BEAVERS, age 48, of Martinsburg, West Virginia, charged with two counts of Delivery of Heroin, Delivery of Cocaine, and Conspiracy to Deliver Cocaine.

TIMOTHY OTTICE BREWSTER, age 24, of Martinsburg, West Virginia, was charged with Possession with Intent to Deliver Marijuana and Driving While License Suspended or Revoked. In a separate indictment, BREWSTER was also charged with Possession with Intent to Deliver Marijuana, Conspiracy to Possess with Intent to Deliver Marijuana, Forgery of a Public Record, Identity Theft, and Driving while License Suspended or Revoked.

CHARLES CONRAD BUFORD, IV, age 46, of Martinsburg, West Virginia, was charged with Possession with Intent to Deliver Heroin, Possession with Intent to Deliver Cocaine, Possession of Marijuana, Fleeing from a Law Enforcement Officer by Means Other than Use of a Vehicle, and Refusal to Fingerprint Upon Arrest.

MICHAEL L. BURACKER, age 31, of Martinsburg, West Virginia, was charged with three counts of Delivery of Heroin and two counts of Conspiracy to Deliver Heroin.

HAZELLEN CLARK, age 30, of Martinsburg, West Virginia, was charged with Robbery First Degree, two counts of Burglary, and one count of Petit Larceny.

IRON LATEEF DAYE, age 39, of Inwood, West Virginia, was charged with Robbery First Degree, Assault During the Commission of a Felony, Malicious Assault, and Domestic Battery. In a separate indictment, DAYE was also charged with Delivery of Heroin, Possession with Intent to Deliver Heroin, and Possession with Intent to Deliver Cocaine.

CLIFFORD GILLIAM EDWARDS, age 47, of no fixed address, was charged with Breaking and Entering.

LOIS JEAN FELTNER, age 52, of Martinsburg, West Virginia, was charged with Delivery of Heroin and Conspiracy to Deliver Heroin.

CODY LEE GORMAN, age 25, of Martinsburg, West Virginia, was charged with Grand Larceny and Trespassing.

VINCENT LIONEL GRANTHAM, age 42, of Martinsburg, West Virginia, was charged with three counts of Delivery of Cocaine. In a separate indictment, GORMAN was also charged with Robbery Second Degree.

NICOLE MARIE HARCROW, age 39, of Martinsburg, West Virginia, was charged with Possession with Intent to Deliver cocaine, Possession with Intent to Deliver Heroin, Conspiracy to Possession with Intent to Deliver Cocaine, Conspiracy to Possession with Intent to Deliver Heroin, and three counts of Gross Child Neglect Creating Substantial Risk of Serious Bodily Injury.

AUSTIN STEVEN HESS, age 24, of no fixed address, was charged with Robbery in the Second Degree.

STEVEN E. HUFF, SR., age 37, of Hagerstown, Maryland, was charged with Burglary, Malicious Assault, Assault During the Commission of a Felony, Breaking and Entering an Automobile, Petit Larceny, and Injuring or Tampering with Vehicle.

MAUDE BERNICE JOHNSON, age 43, of no fixed address, was charged with Felony Destruction of Property.

RACHEAL LYNN KERILL, age 37, of Martinsburg, West Virginia, was charged with Felony Destruction of Property.

KYLE BRADLEY KOONTZ, age 32, of Martinsburg, West Virginia, was charged with Grand Larceny, Flee from Law Enforcement Officer by Means Other than Use of Vehicle, and Obstructing an Officer.

MONTEZZ TARYLE LINCOLN, age 33, of Martinsburg, West Virginia, was charged with Possession with Intent to Deliver Heroin, Possession with Intent to Deliver Cocaine, Possession with Intent to Deliver Oxycodone, Possession with Intent to Deliver Hydrocodone, and Third Offense for Driving While License Suspended or Revoked.

MARIO NELSON PORTILLO MEDRANO, age 29, of Silver Spring, Maryland, was charged with six counts of Sexual Abuse in the First Degree.

TIFFANY MARIE MELBOURNE, age 34, of no fixed address, was charged with Third Offense for Shoplifting.

MALINDA R. MUMAW, age 29, of Martinsburg, West Virginia, was charged with Conspiracy to Deliver Heroin.

SHERRY NALLEY, age 37, of Martinsburg, West Virginia, was charged with Malicious Assault and Attempted Murder.

MELISSA NEICE, age 51, of Martinsburg, West Virginia, was charged with Conspiracy to Deliver Heroin.

WAYNE ANDREW NEMITH, age 24, of Martinsburg, West Virginia, was charged with Burglary and Obstructing an Officer.

NATASHA NUNEZ, age 29, of Martinsburg, West Virginia, was charged with two counts of Delivery of Heroin and two counts of Conspiracy to Deliver Heroin.

JUSTIN MICHAEL PENNINGTON, age 21, of Martinsburg, West Virginia, was charged with Robbery First Degree, Conspiracy to Commit Robbery, and Assault During the Commission of a Felony.

EMILY RENEE PHILLIPS, age 20, of Berkeley Springs, West Virginia, was charged with Possession with Intent to Deliver Marijuana and Conspiracy to Possess with Intent to Deliver Marijuana.

AARON JAMES POUNDS, age 21, of Martinsburg, West Virginia, was charged with Possession with Intent to Deliver cocaine and Possession with Intent to Deliver Oxycodone.

CHRISTOPHER WADE REBISH, age 29, of Martinsburg, West Virginia, was charged with Attempted Murder, three counts of Malicious Assault, Burglary, Robbery First Degree, and Fleeing from a Law Enforcement Officer with Reckless Indifference.

WILLIAM LEE ROBINSON, age 47, of no fixed address, was charged with two counts of Burglary, two counts of Grand Larceny, and Misdemeanor Destruction of Property.

BRANDON SCOTT ROCKINBERG, age 34, of Martinsburg, West Virginia, was charged with Malicious Assault, Domestic Battery Third Offense, and Unlawful Restraint.

All charges contained in the above-referenced indictments are merely accusations and not evidence of guilt. Each defendant is presumed innocent until and unless proven guilty.
