***Indictments Returned on Thursday, October 19, 2017
By the October, 2017 Term of the Berkeley County Grand Jury***

MARTINSBURG, WV – On Thursday, October, 19, 2017, the October 2017 term of Grand Jury convened at the Berkeley County Judicial Center for the final day of deliberations. Over the course of three days, the October Grand Jury Term returned indictments against a total of eighty-seven individuals. On Thursday, the Grand Jury returned indictments against the following, who are presumed innocent unless and until proven guilty:

ROBIN MAE BURNETT, age 43, of Falling Waters, West Virginia, was charged with Delivery of Oxycodone, and two counts of Delivery of Oxycodone and Fentanyl.

ADAM DONAHUHE CULLEN, age 43, of Hedgesville, West Virginia, was charged with five counts of Felony Failure to Register as a Sex Offender.

LIONEL DAVIS, age 40, of Martinsburg, West Virginia, was charged with Third Offense Driving Under the Influence of Alcohol and Driving While License Revoked for DUI.

IRON LATEEF DAYE, age 43, of Martinsburg, West Virginia, was charged with Delivery of Heroin.

GARY WAYNE DILLOW, JR., age 21, of Inwood, West Virginia, was charged with two counts of Malicious Assault and Domestic Battery.

GERALD F. FAUVER, age 53, of Bunker Hill, West Virginia, was charged with two counts of Sexual Abuse in the First Degree and two counts of Sexual Abuse by Parent, Guardian, or Custodian, or Person in a Position of Trust.

ANTONIO FELICIANO, age 44, of Martinsburg, West Virginia, was charged with Felony Failure to Register as a Sex Offender.

AARON TYLER FRAZIER, age 32, of Martinsburg, West Virginia, was charged with Possession with Intent to Deliver Cocaine, Possession with Intent to Deliver Methylenedioxyamphetamine (MDMA), Possession with Intent to Deliver Lysergic Acid Diethylamide (LSD), Possession of Marijuana, Transporting and three counts of Transporting a Controlled Substance into the State.

JEFFREY HAZLETT, age 47, of Martinsburg, West Virginia, was charged with two counts of Sexual Abuse in the First Degree.

SHARKEEL NARRISTA HESLOP, age 23, of Brooklyn, New York, was charged with Possession with Intent to Deliver Heroin, Possession with Intent to Deliver Cocaine, and Possession of Marijuana.

ANDREW PARKER HUMAN, age 24, of Martinsburg, West Virginia, was charged with Wanton Endangerment and Domestic Assault.

ERIK KELLOGG, age 22, of Bristol, Tennessee, was charged with five counts of Sexual Assault in the First Degree.

MARTINA D. KENDIG, age 41, of Martinsburg, West Virginia, was charged with Second Offense for Battery on a Law Enforcement Officer and Obstructing an Officer.

AMY MICHELLE LITTLE, age 35, of Martinsburg, West Virginia, was charged with five counts of Conspiracy to Deliver Heroin.

MICHAEL WAYNE NAPIER, age 40, of Harpers Ferry, West Virginia, was charged with Soliciting a Minor Via a Computer.

WAYNE ANDREW NEMITH, age 24, of Martinsburg, West Virginia, was charged with Burglary, Grand Larceny, and Attempted Burglary.

WILLIAM WARREN PAIRE, JR., age 22, of Myersville, Maryland, was charged with Soliciting a Minor Via a Computer.

JEANETTA RODEEN PETERSON, age 39, of Hedgesville, West Virginia, was charged with two counts of Sexual Assault in the First Degree and two counts of Sexual Abuse by a Parent, Guardian or Custodian.

CHRISTOPHER WADE REBISH, age 29, of Martinsburg, West Virginia, was charged with four counts of Attempted Murder and twenty-one counts of Wanton Endangerment.

DEVIN LAMAR RICHARDSON, age 24, of Roanoke, Virginia, was charged with Possession with Intent to Deliver Cocaine, Conspiracy to Possession with Intent to Deliver Cocaine, Possession with Intent to Deliver Heroin, Conspiracy to Possession with Intent to Deliver Heroin, two counts of Transport a Controlled Substance into the State, and two counts of Conspiracy to Transport a Controlled Substance into the State.

DERRICK EUGENE ROBERTS, age 28, of Clear Springs, Maryland, was charged with Sexual Assault in the Second Degree.

JUSTIN WAYNE ROSS, age 29, of Martinsburg, West Virginia, was charged with three counts of Felony Failure to Register as a Sex Offender.

CODY ALAN SILVER, age 27, of Martinsburg, West Virginia, was charged with Sexual Abuse in the First Degree, four counts of Sexual Abuse by Parent, Guardian or Custodian, or Person in a Position of Trust, three counts of Sexual Assault in the First Degree, and three counts of Incest.

ALBERT AARON SMITH, age 24, of Martinsburg, West Virginia, was charged with three counts of Felony Obtaining Money or Goods by False Pretenses.

RAHEEM JIHAD TIMBERS, age 24, of Martinsburg, West Virginia, was charged with Possession with Intent to Deliver Heroin, Possession with Intent to Deliver Cocaine, Possession with Intent to Deliver Marijuana, Conspiracy to Possession with Intent to Deliver Heroin, Conspiracy to Possession with Intent to Deliver Cocaine, and Conspiracy to Possession with Intent to Deliver Marijuana.

JASON WAYNE UNGER, age 29, of Gerrardstown, West Virginia, was charged with nine counts of Conspiracy to Deliver Heroin.

LINDSEY DIANNE WILHELM, age 30, of Martinsburg, West Virginia, was charged with Possession with Intent to Deliver Heroin, Possession with Intent to Deliver Cocaine, Possession with Intent to Deliver Marijuana, Conspiracy to Possession with Intent to Deliver Heroin, Conspiracy to Possession with Intent to Deliver Cocaine, and Conspiracy to Possession with Intent to Deliver Marijuana.

BARRY WAYNE WILHELM, JR., age 24, of Martinsburg, West Virginia, was charged with Possession with Intent to Deliver Heroin, Possession with Intent to Deliver Cocaine, Possession with Intent to Deliver Marijuana, Conspiracy to Possession with Intent to Deliver Heroin, Conspiracy to Possession with Intent to Deliver Cocaine, and Conspiracy to Possession with Intent to Deliver Marijuana, and Possession of a Firearm by a Prohibited Person.

All charges contained in the above-referenced indictments are merely accusations and not evidence of guilt. Each defendant is presumed innocent until and unless proven guilty.
