### **Indictments Returned By the October, 2020 Term of the Berkeley County Grand Jury**

MARTINSBURG, WV – Berkeley County Prosecuting Attorney Catie Wilkes Delligatti announces that on Tuesday, October 20, 2020, the October 2020 term of Grand Jury was convened at the Berkeley County Judicial Center. Grand Jury deliberations lasted through Friday. The Berkeley County Prosecutor's Office announces that the Grand Jury returned a total of ninety-nine Indictments.

Indictments were returned against the following individuals for the following counts.

BONI FACIO ARAMBURO aka "BONELLI", 36, of Martinsburg, West Virginia, was charged with two counts of Distribution of Heroin, Distribution of Fentanyl, and Conspiracy to Distribute Fentanyl.
