Indictments Returned By the February, 2021 Term of the Berkeley County Grand Jury

MARTINSBURG, WV – Berkeley County Prosecuting Attorney Catie Wilkes Delligatti announces that on Tuesday, February 16, 2021, the February 2021 term of Grand Jury was convened at the Berkeley County Judicial Center. Grand Jury deliberations lasted through Monday, February 22. The Berkeley County Prosecutor's Office announces that the Grand Jury returned a total of seventy-six (76) indictments.

Indictments were returned against the following individuals for the following counts.

MIRANDA LEIGH ARRINGTON, 35, of Falling Waters, West Virginia, was charged with two counts of Transporting a Controlled Substance into the State, Delivery of Buprenorphine, and Felony Drug Conspiracy
